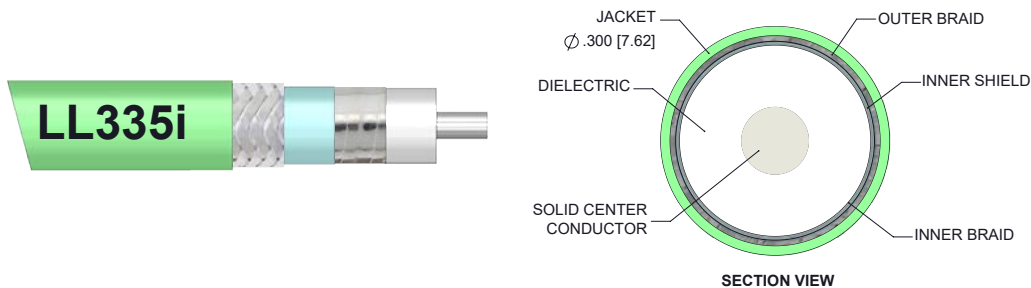

### Description

L-com's LCCA30036-FT5 is a low loss SMA male to N male cable assembly with heavy duty heat shrink boot using LL335i coax, 5 FT and ships same-day. The LL335i coax of this SMA cable uses the tape wrapped PTFE dielectric with a VoP of 83%, resulting in very low insertion loss compared to solid dielectrics. These flexible RF cable assemblies are ideal for applications where flexure is required. Our L-com SMA to N cable assembly has a male to male gender configuration with flexible LL335i series coax and operates to 18 GHz. The triple shield of this SMA cable is layered by silver plated copper braid over silver plated copper tape providing excellent shielding effectiveness greater than 95dB. Highly durable stainless-steel connectors and heavy-duty booting extend the life of these versatile, flexible SMA to N cables.

Custom versions of this SMA male to SMA male cable, along with the rest of L-com's other RF assemblies, can also be built and shipped same day. Other available RF cable assembly value added services from L-com include connector orientation or clocking, heat shrink booting and custom labeling.
